Making the most of your gift

Completion of a Gift Aid declaration allows Moreton Hall Educational Trust, as a charity, to reclaim income tax at the basic rate, on any gift you make. This means every £10 you give can be worth £12.50 to Moreton Hall at no cost to you.

The declaration applies to any future gift you may make, although no future obligation is implied. You must pay an amount of tax (income and/or capital gains tax) at least equal to the tax that will be reclaimed on your gift in the relevant tax year. You may cancel the declaration at any time by notifying the Foundation Office. Please complete and sign the declaration to make your gift tax-effective in this way.

Higher-rate tax payers can claim further tax relief on their personal income tax returns.

A gift of £100 may therefore cost the donor just £75.00 but be worth £125 to Moreton Hall. Every little helps. Your donations, in whatever form or amount, will be most welcome and greatly appreciated.
